Scenario: On his latest visit to a Family Home Care facility a program evaluator learns that the Provider has just accepted a sixth child into care. The single room of the facility is 200 square feet, which the provider claims exceeds the 180 square ft requirement for six children. The PE, however, notes that the room also contains a 'cubbie' cabinet for the children's play supplies that is 10 feet long, 3 feet deep and 3 feet high. The Provider objects to considering the cabinet as a subtraction to total square footage since (a) it is only 3 feet high, with a top that is available for play space and (b) it is on wheels and is therefore movable.
